CERTIFICATE OF COMPETENCY

I, Rajiv Kumar Gupta, I.A.S Director of Factories, Punjab, exercising the powers of Chief Inspector of Factories, Punjab, conferred on me under clause (ca) of Section 2 of the Factories Act, 1948 and the rules made thereunder, hereby recognize Sh Vikas Mahajan of M/s: Jandial Engg. & Allied Services, 345-346, Eldeco Greens, Nakodar Road, Jalandhar to be competent person for the purpose of carrying out tests, examinations, inspections and certification of dangerous machinery, lifts and hoists, lifting machines and lifting tackles and pressure plants and equipments as the case may be, used in factories located in the State of Punjab under Sections 21(2), 28, 29, 31 and 87 of the Act ibid and the Rules made thereunder.

1. The tests, examinations and inspections shall be carried out in accordance with the provisions of the Act and the Rules made thereunder.
2. The tests, examinations and inspections shall be carried out under the direct supervision of the occupier/manager/safety officer/concerned officer.
3. Copies of examination reports shall be sent to the concerned Deputy/Assistant Director of Factories in all cases with a copy to Director of Factories, Govt. of Punjab, SAS Nagar.
4. The Director of Factories, Punjab reserves the right to revoke, annul or amend or cancel this certificate at any time during its validity without assigning any reasons thereof.
5. All the testing facilities at the disposal of competent person shall be maintained in good working order.
6. The Competent Person shall attach his photograph along with occupier/manager/safety officer/concerned officer by standing in front of the equipments/plants/machines examined in the factory under the subject cited sections with the examination/testing report. The photograph shall also contain the name of the factory and the date of examination/tests.
7. All testing reports should be submitted at director.factories@punjab.gov.in within 48 hours of testing and also submit the list of factories tested on monthly basis before 7th of every month.
8. It will be sole responsibility of concerned to follow the rules and instructions as issued by the department and the concerned authorities from time to time.
